## EWG: major activities in 2025

- ◆ Hold FWG 69 & Associated Meetings from 24 to 27 February in Gyeongju in the SOM1 clusters
- ♦ Hold EWG 70 & Associated Meetings from 25 to 26 August in Busan in the SOM3 clusters
- **◆** Hold the 15th APEC Energy Ministerial Meeting from 27 to 28 August in Busan.
- Hold Joint Expert Group Meeting (EGEEC, EGNRET, EGEDA and EGCFE) from 8 to 11 April in Hong Kong, China.
- Seek endorsement of the EWG Strategic Plan for 2025-2030 within this year.
- Seek endorsement of the updated ToR of EWG and its subsidiary bodies within the year.
- ◆ Draft EWG's annual fora report for endorsement by EWG and SCE for the 2025 APEC Senior Officials' Report on Economic and Technical Cooperation.
- Conduct Deputy Lead Shepherd selection process (2026-2027 term) during EWG70.



## EWG: Key Deliverables in 2025

- Ministerial statement for 15th EMM in 2025 (6 drafting meetings will be held virtually b4 August; it needs to be endorsed by EM)
- 3 EWG will deliver Summary reports or hold workshops based on 25 projects
- 4 APEC Urban Energy Report 2024 (Storage Enables Transition) will be published by APSEC in this summer
- 9th edition of APEC Energy Demand & Supply Outlook will be published by APERC in this Autum (This outlook is published every 3 years, and it is the basis of energy policy dialogue within EWG and among APEC energy ministers)




**APEC Energy Demand and Supply Outlook** 



## Alignment with APEC 2025 priorities

➤ Under the overarching theme of "Building a Sustainable Tomorrow", the EWG is guided by the priority of "Accelerating the transition to clean energy" and set 3 key agendas for 2025 APEC EMM, together with the 2025 APEC host ROK:



➤ Based on an energy policy dialogue in Feb, EWG will support ROK to propose APEC policy guidance on the 3 Key Agendas in Aug.

- With IEA IEF & IRENA on energy data



#### SCE RECOMMENDATION ON THE RENEWAL OF EWG

#### Last August 2024, the SCE recommended EWG with 5 instructions for action:



- 1. The EWG, Expert Groups, Research Centres, Task Forces and Satellite Websites (APEC Energy Standards Information System (ESIS) and The Energy Smart Communities Initiative (ESCI) to draft ToRs with four-year time horizons, sunset clauses and submit for SCE approval in advance of 31 December 2025.
- 2. The Expert Groups, Research Centres and Task Forces ToRs to commit to reporting back to EWG annually; to adhering to APEC guidelines and policies, including ensuring that APEC-branded outputs are first endorsed by EWG.
- 3. The EWG to update its' Strategic Plan.
- 4. The EWG to review all websites and instruct relevant members to update/discontinue websites non-compliant with APEC policies or out of date. In the event no economy is responsible for a website, it is to be discontinued.
- 5. The EWG to report to SCE on its actions by SCE1 in 2025

As instructed above, WE EWG has actively and firmly taken steps since last September.

#### **ACTION1:**


### We Updated ToR for EWG



- The renewed EWG ToR with another 4-year time horizon (start from 1 January 2026 to 31 December 2029) was drafted by Former LS Ms. Ari in October 2024
- We expanded <a href="Scope of Activity">Scope of Activity</a> by adding a new goal "to triple renewable energy capacity globally" as a response to Leader's instruction.
- We expanded <u>Priority Activities</u> by adding new initiatives, like Just Energy Initiative Transition (<u>JETI</u>), Energy Access Initiative (<u>EAI</u>) and new APEC policy guidelines on low-carbon clean H2.
- ➤ It was circulated and discussed 3 times within EWG. Only 1 or 2 minor elements left to address.
- > It will be endorsed within EWG very soon.

#### **ACTION2:**

# We updated ToR for Subsidiary



- ➢ 6 renewed ToRs, including that for 2 centers and 4 EGs were also drafted with four-year time horizons and searched for endorsement twice within EWG;
- All the ToRs of the 6 subsidiary bodies incorporated a clause with ccommitments to reporting back to EWG annually; to adhering to APEC guidelines and policies, including ensuring that APEC-branded outputs are first endorsed by EWG.
- The 3 ToRs for 2 centers and 1 EG (APERC, APSEC and EGEDA) were already endorsed in Feb.
- The 2 ToRs for EGEEC (3rd draft) and EGNRET (2nd draft) is now circulated to seek EWG endorsement.
- The EGCFE Secretariat is seeking approval from EGCFE members. Once finalized, the ToR will be circulated for EWG endorsement.
- 1 TF, i.e., ERTF is being reorganized as agreed by members at EWG 69. The ERTF ToR is already drafted but will be renewed soon.
- Regarding ESCI, CT, the host of ESCI initiative, have been drafting the ToR for ESCI. We will circulate for endorsement to EWG once received from CT.

# We Deleted Website Outdated




- The ESIS (Energy Standard Information System) link from the APEC Energy Webpage was deleted in January, as consensus was reached not to further maintain the APEC ESIS website among EGEEC members, as early as in September 2019.
- The website ESCI-KSP is still under working. Thus, it is instructed to use the APEC brand and to prepare a new ToR. ESCI ToR will be prepared by Chinese Taipei and endorsed by EWG and then by SCE within this year.

#### **ACTION4:**

#### **We Updated Strategic**





- ➤ EWG Strategic Plan for 2025-2030 was drafted by Former LS in Dec 2024
- ➤ EWG tried to finalize the endorsement before EWG69 in late Feb, but failed due to new requests on revision.
- > It is under review for 5th time.
- It maybe discussed further inter-sessionally. It is expected to be finalized by early August.


